Knowledge Graph Infrastructure / Cross-Platform Ontology Standards

- OMG's Ontology Platform Special Interest Group (PSIG) has been an active, contributing working group for 15+ years
- Platform standards published:
 - ✓ Ontology Definition Metamodel (ODM) ODM 2.0 planned for Q3/Q4 2020
 - ✓ Distributed Ontology, Model and Specification Language (DOL) DOL 1.1 planned for December 2020
 - ✓ Languages, Countries and Codes (LCC) LCC 1.2 planned for Q3 2020
 - ✓ MOF to RDF Mapping MOF2RDF 1.0 published in March 2020
- Platform standards in work:
 - ✓ APIs for Knowledge Platforms (API4KP) revised submission planned for Q3 2020
 - ✓ Multiple Vocabulary Facility (MVF) revised submission planned for Q3 2020



Ontologies at OMG

Domain standards published:

- ✓ Financial Industry Business Ontology (FIBO) FIBO 2.0 is planned for Q3/Q4 2020
- ✓ Financial Instrument Global Identifier (FIGI) FIGI 1.1 is planned for September 2020
- ✓ Information Exchange Packaging Policy Vocabulary (IEPPV) update planned for 2020

Domain standards in work:

- ✓ Robotic Service Ontology initial submission planned for December 2020, joint effort with the IEEE Robotics community
- ✓ Unified POS Fiscal API / Digital Receipt API initial submission planned for June 2020 (includes preliminary Retail Industry Ontology, mainly for digital receipts)



Business Modeling & Integration Related Standards

- Case Management Model and Notation (CMMN) 1.1
- Decision Model and Notation (DMN) 1.3
- Date Time Vocabulary (DTV) 1.3 (a subset is used in FIBO)
- Pedigree and Provenance (PP) in work
- Production Rule Representation (PRR) 1.0
- Semantics of Business Vocabularies and Rules (SBVR) 1.5
- Standard Business Report Model (SBRM) presented in March 2020, coming soon



Ontology PSIG Roadmap

- RFC for the Architecture Board's Specification Metadata
 - ✓ Currently used by all OMG ontology standards
 - √ Also used in OMG Specification Catalog automation
 - ✓ RFC would include support for UML models & profiles, IDL
- Guidelines for ontology publication and maintenance at OMG
- Extensions to the ODM to support RDF* / SPARQL* (potentially)
- Continued support for any task force that wants to publish an ontology as an OMG standard
- Collaboration with the AI Task Force & migration from ADTF to AI for new platform standards publication as appropriate
